

River Springs Charter School Hemet Quest and Renaissance Student Centers (Grades 7-12) Memorandum of Understanding

As a parent/guardian and student of Springs Charter School, Hemet, I understand and agree to the following:

School Uniforms: I will obtain and wear the school uniform as outlined in the dress code policy at all school functions unless specific permission is sent home for special activities. Students who have multiple offenses will meet with parents and principal to discuss possible program placement change.

Personal Technology: I understand that personal technology is allowed on campus and may only be used in the building for educational purposes with expressed permission from the instructor. Use of technology (texting, social media, etc.) during class time is not allowed and technology will be confiscated and picked up by parent only. Photos and videos taken without expressed permission from the subject (student or teacher) is not allowed; any findings of this used in a harmful or demoralizing manner will be addressed as a disciplinary action.

Mandatory Tutoring: Students who are not making adequate progress by completing at least 70% of coursework in one course will be required to attend inquiry-based tutoring once per week until student is showing consistent progress. Exact times will be assigned at the site.

Drop off and Pick up: Students may be dropped off no earlier than 15 minutes before school and must be pick up no more than 15 minutes after school (with the exception of after school activities). Consistent early or late pick up, will result in a meeting with principal and a probationary contract.

Parking Lot Etiquette: The parking lot and drop off areas are considered part of the school property. All laws must be followed including texting and driving, hands free devices, handicap parking, double parking, leaving vehicle unattended in the drop off aisle, and leaving children unattended in a vehicle. The first offense will result in a meeting with Principal or designee and may include immediate law enforcement contract. Continued parking lot concerns will result in a request to park on the street and walk the student to the campus. Student drivers are expected to adhere to the same parking lot expectations as well as state driving laws for minors. Students must receive approval (parking pass) to park on school campus.

Presentations of Learning (POL): Students and parents will participate in Presentations of Learning at each semester's end. Options to accommodate times, within reason, will be made to families. This is a Hemet Student Center obligation and part of the student agreement.

Attendance: Attendance is calculated upon work completion and not merely physical attendance. The parent and student are aware that the student is expected to complete all assigned work and return to the teacher on its due date. Failure to make progress as a result of poor attendance/work completion will result in an academic contract and possible removal from program with a SARB recommendation with the District Attorney.

Volunteers: We love and appreciate our volunteers. For the safety and privacy of our school community members, all volunteers must follow the volunteer process. All volunteers must check in at the front office, sign in, and wear a badge. Under no circumstances, may a volunteer share the confidential matters of any student, staff, parent, or guardian with anyone. Failure to observe this will result in immediate removal from the position.
